The Government of India vide Notification published in Gazette of India, Extra ordinary Part I dated 01st June, 2017 has resolved to celebrate "Ayurveda Day" every year on the auspicious day of 'Dhanwantari Jayanti - Dhanteras'. It is requested to propagate the campaign to masses through your communication channels including website, social media, and display of banner/standee at the registration counters of hospitals/public places and such other means.

- 5. The activities undertaken by various organizations and stakeholders along with photographs may be posted on the 9<sup>th</sup> Ayurveda day microsite. As a token of appreciation to the initiatives you have taken, the Ministry of Ayush will explore to showcase the best activities reported, during the central function of Ayurveda day.
- 6. In this noble cause, your invaluable support and esteemed cooperation is solicited to promote 9<sup>th</sup> Ayurveda Day 2024 by organizing various activities to garner maximum number of participation. The event details including nodal agencies for organizing various activities may be seen at **Annexure I and II.**
- 7. Your active participation in grand celebration of 9<sup>th</sup> Ayurveda day is highly appreciated.


